## Articulated & Rigid Lorry With Mechanical Forklift Applicable For Most Turf Deliveries 160+

**Pallet dimensions and weight**

44 tonne max

**Height and width**

3.0m 10'0"

Sufficiently wide

**Maximum slope**

Reasonably level

Very steep slopes will possibly prevent delivery

**Ground conditions**

Hard and even ground

Most conditions will not inhibit delivery

Any number of m<sup>2</sup> on pallet up to 80m<sup>2</sup>

**Unloading facility**

3WD lorry mounted forklift

Max. unloading distance from parked lorry to site = 200m
